# 2007.-2017. – Preservation of biodiversity on protected pasture Gajna by breeding original Croatian breeds



Gajna is a multifunctional area – a natural retention, a protected area, a common pasture and a place of education. Securing conditions for ecological livestock grazing is crucial to preserve the biodiversity of the protected pasture Gajna so much of BED's activity is currently focused on maintaining conditions and grazing on this pasture.

When the livestock disappears and the invasive species prevail, grasslands lose their special diversity of the plant and animal world.


### FLOODS IN 2017.

On the Oprisavci part of Gajna ,the water started entering the depressions on the 07.02.2017., it reached its maximum on the 08.02.2017. (605) and then it started withdrawing.

In March the flood was complete, Sava covered Gajna 09.03.2017. with the water level being the highest at 702 on the 10.03.2017.

On the Poljanci part, Sava floods when the water level is around 680.

In December, (14.12.2017.) Sava entered Velika Gajna and it stayed high until the end of the month – the maximum being 695. Green lines are regular floodings that bring water to the depressions, red lines mean extraordinary conditions –e.g. cattle evacuations



## SMART SCHOOLS— INTERREG CBC CRO-BIH-MNE

A transboundary project called 'Innovative minds for smart schools', INTERREG-IPA CBC Cro-Bih 2016. deals with energy efficiency schools with the total value of 1.644.127,82 EUR. It started on 1st June 2017.

Brod Ecological Society BED, joined with the Green Action, Brod-Posavina County, the Tuzla Canton under the leadership of the Centre of Development and Support (CRP) with their headquarters in Tuzla, take part in the project.

The project lasts 27 months, in which an energy efficieny renovation of a school in Brod-Posavina County (OŠ Sibinj) is planned as well as 6 elementary and high schools in the Tuzla Canton. More than 29.000 students, teachers and headmasters are involved in the project.

The main focus of the project is educating and bringing to the public eye the uses of energy efficiency and using renewable sources of energy.



# SMART SCHOOLS – INTERREG CBC CRO-BIH-MNE

Apart from energy efficiency renewals of schools, the project includes

- a four month competition of elementary and high schools in saving energy in the project area,
- a competition of elementary and high school students(individuals) in the project area u IT/technical innovations in the jurisdiction of renewable energy sources,
- two fairs of innovations/solar festivals which will take place in newly-equipped solar laboratories in winner schools,
- energy saving competitions during which the students-participants of the seven-day summer camp for young innovators will present themselves to the public,
- two six-day seminars for training energy managers from the project area
- seven opening ceremonies for renewed school objects, seven follow-up round tables and two final forums (one in Slavonski Brod and one in Tuzla both with transboundary participation) all of them focusing on environmental, financial i bussines benefits of increasing energy efficiency in construction of buildings.



# SMART SCHOOLS – INTERREG CBC CRO-BIH-MNE

A four-month competition of elementary and high schools in the project area (energy saving).

The opening ceremony was held in Tuzla, 05.12.2017.

105 schools have applied to the competition, 81 schools from the Tuzla canton (BiH) and 24 schools from Brodposavina county (HR), a obuhvaća ukupno 37 596 korisnika objekata osnovnih i srednjih škola.

The goal of the competition is promotion of energy efficiency and energy and water saving, without any additional investments, just by changing the behaviour of the users of the object.





# Project proposals and fundraising—submitted and/or signed in 2017.

Innovative minds for smart schools (INTERREG-IPA CBC CRO-BIH 2016.) - submitted project proposal in which we participate with the Zelena akcija from Zagreb and the Center for Development and Entrepreneurship (CRP) from Tuzla, Brod-Posavina County and Tuzla Canton. The theme of the project is rebuilding energy efficient schools, total budget is around 1,600,000.00 EUR, of which approx. 50.000 EUR is for BED

**Institutional support** - The request was submitted on 12.09.2016; 23.09.2016. we received a confirmation that the administrative check ran in order; 24.11.2016. we had field check-up from the National Foundation for Civil Society Development, which contributed to the positive endorsement of the Institutional Support for 2017. Requested HRK 199,990.10 and approved 147,690.00 HRK

Keeping the tradition - preserving nature — Brod/Posavina County and Public Institution Natura Slavonica have submitted the project proposal for a call "Promotion of the sustainable development and natural heritage". BED contributed to the project as a partner. The entire project was worth 3.481.556,36 HRK, and BED's co-financing share was 26.511,74 HRK. The project was not approved.



### **GAJNA** as an example

BED is active in international arena in networks concerning common governance- 23.-25.10.2017. workshop on natural common governance for Europe and Middle East in Granada, Spain and 24.-29.11.2017. the Office of high representative of human rights as on of UN bodies organized UN forum on Buisness and human rights in Geneve. As one of the members of the global alliance ICCA Consortium BED advocates rights of local communities and indigenous peoples in effort to preserve nature by governing its territories.









### Pasturing community veterans' cooperative Eko-Gajna

Gajna is currently the only place in Croatia, which has with the advocacy of Brod ecological society BED, kept the **common model of governance** on the traditional common grassland and has adjusted such governance to the existing legal framework

BED is the main driver and member of the Pašnjačka zajednica braniteljska zadruga Eko-Gajna in the Oprisavci Municipality near Slavonski Brod and for years has been advocating for alternative models of use and management of protected areas and areas of Natura 2000, especially regarding the traditional use of common pastures that still exist in some parts of the floodplain of the River Sava. The PZBZ Eko-Gajna has adopted the Gajna Management Program which serves as a base for annual programs which contains measures and conditions of nature protection. We have succeeded in amending the Agricultural Land Act in 2015 in that way that the possibility of joint management on common pastures by accepting a collective as a renter of a state owned by Croatia was finally recognizing.



### The Coordination council of significant landscape Gajna

The third 21.02.2017. the Coordination council significant landscape Gajna was held in municipality Oprisavci. The Public institution Natura Slavonica and the municipality Oprisavci and the representatives of: Pasturing community veterans' cooperative Eko-Gajna, Croatian waters, the border police, LAG Slavonian plain, the Museum of Brod Posavlje, the University, the Croatian for the agency environment and nature and many more.



BED, together with the Public institution Natura Slavonica, nourishes cooperation between sectors and participatory ways of governing protected areas.



Sudionici okruglog stola složili su se da pašarenje i žirenje donosi puno više koristi nego štete za šume, a zabrana takvih djelatnosti bila bi dodatan udarac za već posrnulu hrvatsku poljoprivredu.

Since 1989, Gajna has been listed as a protected area under the Croatian Nature Protection Law. It is a grassland protected at a local (county) level and is wholly dependent on the activities and management of the local communities that live in and around it. Within this area, despite the different forms of management grazing over the years, it has always operated within a communal system of governance. Gajna (380 ha) is located in the Croatian fertile lowland, on the flooded grassland of the Sava River, on the border with Bosnia and Herzegovina. It is an area enriched

Supported Organisation (CSO) known as Brod Ecological Society, or BED, has 80% of its membership coming from the two surrounding communities. BED has been actively protecting and maintaining the Gajna area since 1989 by engaging and stimulating the local population to stick to traditional grazing practices, ensuring a favourable water regime, removing the invasive species and preserving the biodiversity thanks to a series of projects they have implemented. After 1990 and the dissolving of the socialist regime, the land was formally listed as property of the

### Structure and the association's regular work

• In 2017. three people were employed: program coordinator, administrative-technical secretary and guardian of Gajna. One person was additionally employed for professional training. The project team (the president, the program coordinator and the treasurer) makes monthly revisions of realised and planned activities and prepares reports for board meetings which are held at least once every two months.

The regular yearly assembly was held on the 26.05.2017. with the report for 2016.


The new Strategic plan for BED (2018.-2020.) was adopted at the assembly.

Apart from three programs, the project **INTERREG CRO\_BIH – Smart schools** (funded by EU funds) is also planned, it began 01.06.2017. and it will last until 01.09.2019. – BED is a partner

**SUSTAINABLE MANAGEMENT OF THE GAJNA PROTECTED AREA** – regular implementation (the basic activities— supplying food for the animals, infrastructure maintenance, mechanical removal of invasive plants in the most critical areas, monitoring biodiversity, veterinary and technical interventions, constant support for breeders and education related to subsidies and lobbying in bodies connected to rural development, ecological network and agri-envieonmental measures, finding a market for such products for long-term sustainability of the program, holding meetings for the Gajna coordination council)

SUPPORT FOR THE CIVIL SOCIETY DEVELOPMENT IN RURAL AREAS – regular implementation (UUSSP – convened meetings with the Minister of Agriculture related to the subsidy payments for traditional breeds; establishment of the Alliance of native bovine breeds RH, communication with the breeders and the Agricultural Paying Agency for printing out Certificates and following the implementation of the breeding program, preparing the yearly assembly and financial and narrative reports, communication with the Office for Public Administration related to alignment according to the latest Law on Associations, forestry associations GAJ, Mrist, Smiljak, KKHPP – continue cooperation through the Gajna coordination council and explore the possibility of participation in joint projects)
